Arbitral Award to DFNN on the Equipment Lease Agreement between DFNN and PCSO

Background/Description of the Disclosure

This is to inform the Philippine Stock Exchange, Inc. that today, DFNN, Inc. (the 'Company') received a copy of the Arbitral Award dated May 21, 2015 in relation to the arbitration proceedings mandated by the Equipment Lease Agreement dated April 9, 2003 between the Company and the Philippine Charity Sweepstakes Office (PCSO).

In its Arbitral Award, the Arbitration Panel ruled that PCSO illegally and improperly terminated the Equipment Lease Agreement (ELA) with the Company. In this regards, PCSO was ordered to pay the Company Twenty Seven Million Pesos (Php27,000,000.00) as liquidated damages, in accordance with the terms of the ELA.
