Subject of the Disclosure

Resumption of Operations of Electronic Entertainment PAGCOR Authorized Sites under MGCQ

Background/Description of the Disclosure

To recall, on 16 March 2020, Philippine Gaming and Amusement Corporation (PAGCOR) directed all licensed casino and gaming sites nationwide to temporarily cease its gaming operations due to the COVID-19 pandemic. On 2 June 2020, DFNN Inc. was informed that PAGCOR shall now allow the gaming sites (except Traditional Bingo Halls) located in low-risk areas placed under Modified General Community Quarantine (MGCQ) by the government to resume its operations at fifty (50%) capacity.

In order to resume operations, the operator of the gaming sites (Operator) shall comply with the "Health and Safety Standards for Resumption of Operations of Gaming Sites" issued by PAGCOR, and shall also submit its "Strategic Guidelines for COVID-19 Prevention" (Strategic Guidelines) to PAGCOR, which shall be evaluated whether it is sufficient or not. Once PAGCOR determines the Strategic Guidelines to be sufficient, it shall issue to the Operator a notice to commence gaming operations. Further, all employees of the Operator must have received a negative COVID-19 test result prior to deployment for work. In sum, our partners who operate gaming sites (except Traditional Bingo Halls) located in low-risk areas placed under MGCQ by the government may resume its operations so long as it complies with the conditions set forth by PAGCOR.
